HEALTH PROBLEM WITHIN 10 DAYS:

If within ten (10) days of receipt of the puppy, your puppy develops a health problem which may have existed at the time you picked up your puppy, the Buyer will notify the Seller immediately (by telephone or e-mail), and no later than two business days of the diagnosis by the veterinarian of the health problem. Buyer will provide the Seller with the name and telephone number of the veterinarian and a copy of the veterinarian's report on the puppy. The Seller will provide the Buyer with one of the following remedies of their choice:

- 1. Buyer will receive a refund of the full purchase price of the puppy. The Buyer will return the puppy and registration papers to the Seller (at the Buyer's expense) within three (3) days of the examination. The Buyer will transfer ownership back to the Seller.
- 2. The Seller will replace the puppy from the next available litter of equivalent value. The Buyer will return the puppy and registration papers to the Seller (at the Buyer's expense) within three (3) days of examination. The Buyer will transfer ownership back the Seller.



3. Receive reimbursement for reasonable veterinary fees, provided such reimbursements do not exceed the original purchase price of the puppy for all veterinarian bills. All reimbursable veterinary fees must be approved by the Seller prior to treatment. Reimbursement will not exceed the original purchase price of the puppy. A copy of the vet bill must be sent to the Seller.

Any expenses incurred on any return puppy or replacement puppy are the responsibility of the Buyer.

We reserve the right to ask for a second opinion from a veterinarian if circumstances are questionable.

This refund, replacement or reimbursement does not include indigestion of foreign objects, ingestion of dangerous plants and chemicals or physical injury contracted or incurred following Buyer's receipt of puppy.

Common problems in puppies include: coccidia, giardia, worms, ticks, fleas, mites, mange, or any other parasites found in dogs.

CONGENITAL DEFECT:

Seller offers a one year guarantee on any puppy found to have a congenital defect (abnormality existing at birth). If within one year after receipt of the puppy the veterinarian diagnosis a congenital defect, the Buyer will notify the Seller within two (2) business days of the diagnosis by the veterinarian of the congenital defect and provide the Seller with the name and telephone number of the veterinarian, and a copy of the veterinarian's report on the puppy. The Seller will provide one of the following remedies:

- 1. Buyer will receive a refund of the full purchase price of the puppy. The Buyer will return the puppy and registration papers to the Seller (at the Buyer's expense) within three (3) days of the examination. The Buyer will transfer ownership back to the Seller.
- 2. The Seller will replace the puppy from the next available litter of equivalent value. The Buyer will return the puppy and registration papers to the Seller (at the Buyer's expense) within three (3) days of examination. The Buyer will transfer ownership back to the Seller.

Any expenses incurred on any returned puppy or replacement puppy are the responsibility of the Buyer.

There are no reimbursements of veterinary treatments or surgeries concerning congenital defects.

The Health Contract does not cover any physical injuries.

The Seller has no control regarding the future temperament, habits and appearance of the dog, development of allergies, trauma or injuries to the puppy and hence does not warrant such.

Seller disclaims any and all representations and warranties, oral or written, except as expressly stated herein.
